



PEOPLES CREDIT UNION ENDOWED SCHOLARSHIP REGULATIONS

In 1994, Peoples Credit Union Ltd. (then Innisfil Credit Union) received an anonymous donation towards an endowed scholarship. This scholarship is in keeping with the Christian principles which helped start the Credit Union in 1944 and which are still applicable today. This scholarship enhances the Credit Union's motto of "People Helping People". Approximately \$1,000 will be available annually to one or more qualified students who have enrolled in a degree program at a Christian educational institution approved by the trustee. An applicant must be a member of Peoples Credit Union, or member referred, and live within a 24.14km (15-mile) radius of the Stroud Branch of Peoples Credit Union located at 8034 Yonge Street, Stroud.

Each scholarship applicant will be required to complete a formal application on the Peoples Credit Union Application form. Such forms may be available at local secondary schools, the Alcona and Stroud branches of Peoples Credit Union and on-line at www.peoplescu.ca. Applications are to be submitted to the chairperson of the committee by **July 3rd, 2006**.

The prime consideration in the selection process will be based on demonstrated financial need.

The scholarship committee will require an interview with all finalists.

In special circumstances: (a) second and third year assistance may be considered and/or (b) more than one recipient may be selected, in which case, the yearly award amount will be divided among such recipients.

Payments of the scholarship amounts will be made to the Bursar of the recipient's institution on the basis of (a) 50% upon confirmation of enrolment and (b) 50% in the second semester, providing the student has attained a 60% average in the previous semester.
